PUBLIC COMMENTS

Sallie Ann Collins questioned if the commercial garbage hauler, Sanford and Sons would be reducing their fees. Comm. John Meeks stated the Board cannot force the haulers to reduce their fees, but the City's are working with them to get a reduction for their customers.

Additional comments regarding the elimination of Landfill tipping fees and the waste hauling companies were made by: Jeff Hardison, Linda Cooper.

Mayor Merritt stated the South Levy Marketplace will be celebrating its 3rd anniversary on the 27th of the month and invited everyone to attend. Mayor Merritt also announced the \$15,000 needed for the Consulting Engineering Contract on the "Whitewater" kayak venue had been raised.

COMMISSIONERS' REPORTS

Comm. Joyner reported of the meeting he had attended recently in Yankeetown regarding the Highway 40 boat ramp. Comm. Joyner stated the local team attending the State Ranch Rodeo placed second.

Comm. Rooks reported of a FAC meeting she had attended in Charlotte County regarding policies.

Comm. Brooks reported of the Withlacoochee Chamber event he attended recently. Comm. Brooks recognized Comm. John Meeks for his dedication and commitment regarding his efforts at the Innovation and Policy Conference he also attended recently. Upcoming events in Williston: Peanut Festival this weekend beginning with the Rotary Club's Purple Pinky Peanut 5K on Saturday morning at 8:00 A.M.

Comm. Rock Meeks stated the Chiefland Homecoming Parade will be this Friday at 4:00 P.M. Comm. Rock Meeks reported the Mosquito Control will be receiving an additional \$35,000 in State funding this year.

Comm. John Meeks announced several upcoming events in Levy County: October 3-7, Hidden Coast Paddling Festival in Cedar Key; Lost Railroad event at Kirby Farms runs through the month of October every Friday and Saturday; Hero's Rodeo at the Horseman's Park in Williston on October 12th and 13th; Country Circus at Two Hawk Hammock in Williston on October 13th and 14th; Cedar Key Seafood Festival on October 20th and 21st; Levy County Beast Feast on October 20th. Comm. John Meeks spoke of internet access for Levy County residents and his discussions regarding this at the meeting he attended in Charlotte County.

Comm. John Meeks asked for consensus by the Board to work with the Building and Zoning Department regarding the permitting fees for company's interested in providing communications towers which would bring better internet access to the citizens of Levy County and it was agreed by the other Commissioners to do so.

Comm. John Meeks requested an update from Atty. Brown or Mr. Dean regarding a meeting in which they both attended with DEP regarding pollution of the Suwannee River by sewage treatment facilities near Valdosta, GA. Atty. Brown gave an update to the Board of the DEP meeting.

Comm. John Meeks reported of RESTORE Act money, which had been approved for Levy County.
